From the Liber Baptizatorum, NNA 2953A-27, Entry no 443:

Translation:

"On 11th August 1878, I the undersigned, did conditionally baptise in the church of the Most Holy Trinity at New Norcia, Western Australia, a man called William Hunt, from the island of England, but actually living in the place commonly called Jiriol of this Benedictine mission. He is about fifty years old and has publicly renounced Protestantism and has accepted the solemn profession of the Catholic and Apostolic faith according to the Holy Roman Church. The witnesses were James, and Anne, the children of William Hunt and Catharine Murphy. [Signed] Bernard Martinez, priest, OSB".

From Bishop Salvado's Diaries, Vol 15:

August 1878 11th 0 Sunday, the 9th after Pentecost. William Hunt was admitted into the Catholic Church and baptised this afternoon.

July 1890 7th 65 Mon. Mr William Hunt died in his house at eleven this morning. He had received all the Holy Sacraments at Marah on Wednesday or Thursday last week.

8th 1866 Tue. W. Hunt's body was brought here this afternoon.

9th 1867 Wed. The funeral began at eight in the morning and the late William Hunt was buried at nine. Mrs Hunt, through her daughter Ann, wanted to pay me for the expenses 1 of the coffin and burial of her late husband, amounting to £7.10s.0d. However, taking into consideration that she's a poor widow with only two daughters, I accepted 30s and gave her back or presented her with £6.

14th 1910 Wed. Early this morning, I sent a spring cart with provisions and eight people to prevent another fire from igniting,

Several fences are burnt, but the family that suffered the most was Mrs Hunt's;2 it was almost a miracle that their houses and farm buildings, fields and everything else didn't burn, but the wheat in one field and several things did.

D. will check these things next week in Perth, where he is going to pay for the lands and settle the account with Mr Shenton. D. says that Br Agaton [Elguezabal] arrived from Woongan [Wongan] Hill on Tuesday, and he is unhappy because, although they have deepened the well about 15ft, it doesn't give water as before; there are 3 diggers and Br [Rosendo] Pich there. D. tells S. that Governor [William Cleaver Francis] Robinson has left [WA] and they are awaiting the new one; Mr [Malcolm] Fraser is the Col. Sec. and Mr [John] Forrest, the Comm. of Crown Lands. On 5.2.83, there were at cricket match at NN between the Newcastle team -captain: Magistrate Oct[avius]. Burt- and the V[ictoria]. Plains team captain: W[illiam]. Boxal [Boxhall] – and the latter won; further comments on the match. Today is raining. Request for blessings. [Salvado's headnote: R. 26.3.83. A. 6.4.83.] (4 pages)

At NN, they are happy with his overcoming the difficulties and they were worried about the Bishop of Barcelona's behaviour; the Catalan brothers are happy about Montserrat being the place selected for the College [for Missionaries]. D. left NN for Perth via Guildford on 6.1.85. In Perth, D. wants to buy some blocks of land and get a Govt reserve [at Marah] before the beginning of the railway works. D. has applied for 2,000 acres in different Ma[r]bro runs, and says that it is a pity that they couldn't secure these lands in the past because, at present, the Hunt's, Longman's and Sheridan's flocks are eating their grass and they are forced to fence the area. They are threshing at NN, and D. hopes to get 3,000 BU of wheat and some hundreds of barley and oats. Last December, D. secured NN reserve thanks to a document from Governor Kennedy, and D. applied for a 25,000 acres reserve at Marah; the Administrator –Mr [Alexander Campbell] Onslow– is well disposed to grant the reserve, but the Executive Council isn't. However, ACO will grant the reserve for 6 months until the return of Gov. [Frederick Napier] Broome. As D. and [George] Shenton told S. in December, it is very important to meet Gov. Broome in London, especially because the Gov. wants to help NN. The European mail arrived yesterday, but D. will get to NN tomorrow and he can't reply to S.'s letter until next week. D. acknowledges S.'s letter dated 8.12.84 and he's glad that S. is ready to give the habit to the postulants. D. says that they have enough Mass [celebrations] for this year. D. is upset at the students' riots in Madrid and thinks it is their teachers' fault. D. will return to Perth in Feb. to pay for the blocks of land. [Salvado's headnote: R. 4.3.85 & A. 5.3.85 from London. Started to write the letter on 2.3.5.] (6 pages)
